

## Refund Policy

### Termination of Service and Refund of Fees

#### Termination by Research Analyst

The Research Analyst can collect a maximum of three months' advance fees, and as per your advance fees, the same validity is provided (if payment is partial, then a pro-rata basis validity of service will be allotted to the client).
